Criteria of selection:-

1. The Candidates, who have applied online & submitted the hard copy duly signed by competent authority and received within the Stipulated time, were only be considered for selection procedure as per UGC-HRDC guidelines, -2015.
2. As per UGC-HRDC guidelines the number of participants for each course / programme should not be less than 30 failing which course / programme will be considered as non-functional and no TA will be provided to the participants if the course is cancelled.
3. As per the letter of UGC F.No1-13/2017 (HRDC) dated 04th June 2018, No dearness allowance will be provided to teacher participants.
4. There is no provision for the spot admission. No candidate will be registered on the spot.


